

#### **Fostering Academic Dialogue**

Under the esteemed direction of SAHSOL, CCLS has played a pivotal role in fostering academic dialogue and understanding among students by organizing insightful sessions aimed at broadening perspectives and enhancing knowledge. The inaugural session of the CCLS Talk Series 24 featured Dr. Humayun Bashir, a distinguished physician in Nuclear Medicine, who shared his expertise on "Globalization of Healthcare Technology and China - A Physician's Perspective." Dr. Bashir highlighted China's significant contributions to global healthcare technology, showcasing breakthroughs like PET-CT scans and innovative solutions by Shanghai United Imaging Healthcare.





We also had the privilege of virtually hosting Dr. Nadeem Omar Tarar, a Senior Research Fellow at the University of Texas, USA, renowned for his expertise in Gandhara cultural heritage and Buddhist heritage preservation in Pakistan. Dr. Tarar shared profound insights on "Bridging Nations: China-Pakistan Collaboration in Buddhist Tourism." Dr. Tarar's session emphasized the critical importance of China's support in Buddhist religious tourism and the economic potential of the China-Pakistan Economic Corridor (CPEC). 


## Celebrating 11 years of CPEC: Connecting Nations, Building Futures

#### **Credited Courses**

### **Chinese Language Courses**

#### **HSK Level 1 Course:**

The HSK Level 1 course introduces Mandarin Chinese, focusing on basic vocabulary, essential grammar, and practical communication skills. Topics include greetings, daily routines, and common expressions, building a foundation in both spoken and written communication for everyday scenarios.

#### **HSK Level 2 Course:**

The HSK Level 2 course prepares students for the level 2 exam by teaching necessary grammar and vocabulary. It covers verb usage, expressions, descriptions, and inquiries in Mandarin, along with more complex sentence structures. Students learn to describe events, compare experiences, and articulate emotions, enhancing their conversational skills and character recognition to advance in the HSK exam.

### China and Global Governance

"China and Global Governance" is a course that explores the evolving dynamics of the international system, focusing on China's role and impact. It addresses political, legal, and social issues, human rights, and security, and examines global governance debates involving states, organizations, civil society, and corporations. The course highlights China's economic rise, its integration into global decision-making, and achievements in poverty alleviation contributions to environmental, financial, and health governance. It also critically examines China's one-party governance model and the "China and the Rules-Based Order" to analyze differing international norms. Students will gain insights into international relations and governance complexities in the 21st century.
